“SMU has leveraged its strong industry relevance of its CET offerings and can further sharpen its value proposition. SMU is rebalancing its portfolio towards more substantive step of all programmes in line with MOE’s planning guidance.

MOE commended SMU’s significant effort in aligning to MOE’s planning guidance to focus on substantive upscaling pathways, shifting from standalone programmes towards more stackable programmes. It had positive views on SMU’s strategy of targeting not only degree holders but also non-degree holders, supporting their upskilling needs.
